- Submit the application downloaded from the official website under Project Announcement (2019 Artience Daejeon Participating Artists Recruitment).
 - * File name: Artience Daejeon Application_Your name (Team name)
- The size of portfolio should not exceed the size limit.
- * Applicants who fail to submit required documents or do not follow the guidelines will be eliminated
- J. Support fund
 - 1) Residency/Collaboration: Support fund up to 5,000,000 KRW; can apply for 2 consecutive years
 - * The support fund for the second year will be calculated separately.
 - 2) Open project: Support fund up to 8,000,000 KRW

 - * PowerPoint file should be submitted after the interviewee list has been announced.
 - * Shortlisted local artists applying for the open project will be individually notified for interview arrangement.
 - * Interviews will not be held for the overseas applicants.



B. Responsibilities

- Participate in Artience Daejeon programs and fulfill the foundation
 -related regulations
- 2) Participate in exchange programs with the collaborating institutions; Collaborate on art-science convergence/integration work
- 3) Submit documents recording the activities
- 4) Participate in the orientation, workshop programs, meetings, performance report presentations (interim, final)
- 5) Submit records of expenses and the performance report within 1 month after termination of the project
- 6) When requested by the collaborating institution, help exhibiting the creative works from 2019 Artience Daejeon inside the institution building

C. Others

- 1) Submitted documents and materials will not be returned.
- 2) The applicants who reject to be interviewed will be deemed as withdrawn.
 - * Interviews will not be held for the overseas applicants.
- 3) The copyright of the work created belongs to the artist. The foundation

- and the institution will be given the reproduction right, performing right, public transmission right, public display right, distribution right, lending right and adaption right without a separate permission of the artist.
- 4) In the following cases, the support fund may be cancelled after a review.
 - A) When failed to perform required activities
 - B) When a disgraceful situation occurs between the participating artists or researchers
 - * Relevant artists will be removed from the residency program and will not be allowed to state the program in their career history.
- 5) The information in the document should be clear and include the details as the document will be used for an applicant review. Applicants who provided insufficient information or false information will face disadvantages such as being eliminated from selection.
- 6) The documents including personal information shall be submitted following acceptance of the agreement on collection of personal information according to Article 15 of the *Personal Information Protection Act*.
- 7) The copyright of the programs required for creative activities of the participating artists must be confirmed in advance.
- 8) All budgets for support fund shall be executed and settled through the integrated government subsidy management system (e-Naradoum).
- 9) Any disadvantages caused by not fully understanding the contents of the announcement is the responsibility of the applicant, and DCAF will not be held responsible.
- 10) There may be changes to 2019 Artience Daejeon due to circumstances.
